
Dear Chairwoman DeLauro and Ranking Member Cole:

Pursuant to the processes outlined by the U.S. House Committee on Appropriations and the U.S. House of Representatives, I am requesting funding for "Healthcare on The Spot" in fiscal year 2022. The entity to receive funding for this project is the Baltimore City Health Department located at 1001 East Fayette Street, Baltimore, MD 21202.

The proposed \$458,370 would be used "to support funding for staff, supplies, medication, maintenance, and create a second 'Health on The Spot' mobile clinic van. The mobile clinic van will be deployed to areas in Baltimore that are in most need and provide services regardless of patients' lack of documentation or insurance status. This proposal will expand access to free, evidence-based, low threshold, PWUD-centered clinical services in communities experiencing high rates of fatal and non-fatal overdose."
