
Dear Chairwoman DeLauro and Ranking Member Cole:

Pursuant to the processes outlined by the U.S. House Committee on Appropriations and the U.S. House of Representatives, I am requesting funding for “Kennedy Krieger Institute Integrated Early Learning Center” in fiscal year 2022. The entity to receive funding for this project is the Kennedy Krieger Institute located at 707 North Broadway, Baltimore, MD 21205.
