The proposed \$4,000,000 would be used to "include comprehensive renovations and upgrades to the organization's current three-story home, which is a cherished pillar not only within the Baltimore community, but beloved by the national and international community. This project would be a valuable use of taxpayer funds because API has a proud history of community service and outstanding dramatic achievements. The organization's primary patron base is predominately African American, and most live and work in Baltimore City and/or the five surrounding counties."
